TORONTO, March 30, 2017 – Global Champions Split Corp. (“Global Champions” or the “Company”) announced today that its net assets per unit, as determined for financial reporting purposes, was \$53.68 at December 31, 2016.

Portfolio securities and net assets totaled \$112 million and \$71 million, respectively, as at December 31, 2016 compared to \$108 million and \$65 million as at December 31, 2015. Net assets per unit consists of one preferred share and one capital share.
