

## GLOBAL RESOURCE CHAMPIONS SPLIT CORP. ANNOUNCES 2016 ANNUAL RESULTS

**TORONTO, March 30, 2017** – Global Resource Champions Split Corp. (“Global Resource” or the “Company”) announced today that its net assets per unit, as determined for financial reporting purposes, was \$48.00 at December 31, 2016.

Portfolio securities and net assets totaled \$86 million and \$54 million, respectively, as at December 31, 2016. The Company commenced operations on May 6, 2016, upon completion of an initial public offering of 1,800,000 Class A Preferred Shares, Series 1 (the “preferred shares”) at C\$25.00 per Share (the “offering”), for gross proceeds of C\$45 million. Concurrent with the Offering, the Company issued 1,800,000 capital shares to Partners Value Fund Investments Inc. for C\$55 million.
